

**CITY OF GOOD HOPE
COUNCIL MEETING MINUTES
JANUARY 14, 2013**

OPEN: The Council meeting was called to order by Mayor Corey Harbison at 6:30 P.M at the Good Hope City Hall. Invocation was given by John Harris.

ROLL CALL: Mayor Corey Harbison, Council members: John Harris, Maxie Jones, Jerry Bartlett, and Matthew Glover were all present. Absent: Council member Susan Eller.

VISITORS: Patti Maner from Regions Bank.

MINUTES: John made a motion to approve and adopt the December 10, 2012 council meeting minutes. The motion was seconded by Maxie Jones. Roll call vote: unanimous yea votes by the Mayor and Council.

PLACE ONE: JOHN HARRIS: John made a motion to accept the bank balances and financial report. The motion was seconded by Maxie Jones. Roll call vote: unanimous yea votes by the Mayor and Council.

PLACE TWO: MAXIE JONES: Maxie stated that he and Corey had been approached by Ann Edmondson to see if the city would be interested in buying the building she owns on Good Hope School Road. Maxie stated that she had said her final price would be \$100,000.00 and that would include the building and almost 1 acre of land. Maxie said the building alone would cost more to build than what she is asking for it. Corey stated he would like to do something to get the street dept. out from in front of City Hall. After discussion Maxie made a motion to purchase the property if she will produce a survey and a clear title. Jerry seconded the motion. Roll call vote: unanimous yea votes by the Mayor and Council.

PLACE THREE: SUSAN ELLER: Absent

PLACE FOUR: JERRY BARTLETT: Jerry stated that he had several gifts that were collected for children in Good Hope. The left over gifts were donated to DHR.

PLACE FIVE: MATTHEW GLOVER: Ball sign ups will be Jan. 26th, Feb. 2nd, and Feb. 9th. in the basement of Good Hope City Hall. The cost is \$60 for tee-ball and \$75 for baseball and softball.
