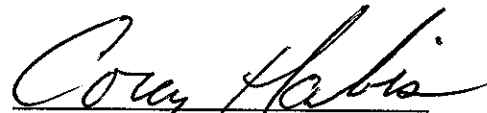
**RESOLUTION #002-2014**

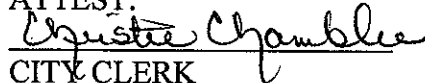
