

ORDINANCE NO: 016-2021

TO AMEND ORDINANCE NO: 003-2012 TO REGULATE THE TIME OF SALE OF ALCOHOLIC BEVERAGES BY RETAIL LICENSEES OF THE ALCOHOLIC BEVERAGE CONTROL BOARD AND OTHERS IN THE CITY OF GOOD HOPE, ALABAMA

BE IT ORDAINED BY THE CITY COUNCIL, AS THE GOVERNING BODY OF GOOD HOPE, ALABAMA, AS FOLLOWS:

WHEREAS, by Legislative Act 2019-100, codified as Ala. Code 1975 Section 28-3-25, the local governing body in any wet municipality may by ordinance permit and regulate the sale of alcoholic beverages on Sunday, after the hour of two o'clock a.m. for on-premises or off-premises consumption, or both, by retail licensees of the Alcoholic Beverage Control Board.

SECTION 1. That Ordinance No 003-2012, also known as the City of Good Hope Alcohol Ordinance, shall be and hereby is amended as follows:

AMEND SECTION 10: AUTHORIZED HOURS

It shall be unlawful, and considered a violation of this Ordinance, for any person, whether a liquor, wine or beer licensee or not, to sell, offer for sale or to serve dispense for offer or reward, or to offer to serve or dispense for reward any liquor, wine, or beer, or to allow the consumption of any alcoholic beverages on the licensees premises between the hours of 12:00 am and 8:00 am on Tuesday, Wednesday, Thursday, Friday or Saturday of any week. Between the hours of 10:00 am to 10:00 pm Sunday it shall be lawful to offer to serve or dispense for reward any liquor, wine, or beer, or to allow the consumption of any alcoholic beverages for on-premises or off-premises consumption, or both, by retail licensees of the Alcoholic Beverage Control Board. It shall be unlawful between the hours of 10:01 pm on Sunday until 8:00 am of the following Monday.

SECTION 2. That all other ordinances or parts of ordinances in conflict hereof are expressly repealed and rescinded.

SECTION 3. That if any part, section or subdivision of this ordinance shall be held unconstitutional or invalid for any reason, such holdings shall not be construed to invalidate or impair the remainder of this ordinance, which shall continue in full force and effect, notwithstanding such holding.


SECTION 4. This Ordinance shall take effect on the first Sunday of the first month following the month during which this Ordinance is approved, adopted and published. **This ordinance will take effect beginning on Sunday July 4, 2021.**
