COUNCIL MEETING MINUTES  
October 28, 2013 @ 6:30 pm**

**OPEN:** The Council meeting was called to order by Mayor Corey Harbison at 6:30 P.M. at the Good Hope City Hall. Invocation was given by Maxie Jones.

**ROLL CALL:** Mayor Corey Harbison, Council members: John Harris, Maxie Jones, Susan Eller, and Matthew Glover were present. Jerry Bartlett was absent.
