COUNCIL MEETING MINUTES
July 28, 2014**

OPEN: The Council meeting was called to order by Councilman John Harris at 6:30 P.M. at the Good Hope City Hall. Invocation was given by John Harris.

ROLL CALL:, Council members: John Harris, Jerry Bartlett, Susan Eller, Maxie Jones and Matthew Glover were present. Mayor Corey Harbison was absent.

VISITORS: Thelma Milligan asked if the city could ask Strickland Septic Tank to either move the port a lets in the back or put up some fencing to make the area look nicer. Council stated they could ask the business to do so but could not guarantee response.


Roll call: unanimous yea votes by the Council.


